The Schedule

Suspicious Circumstances

The Event Evidence is that the Budget Insurance Policy 135348550 01 001 02 dated 7th November 2022 of Mrs Marylin Hawes of car registration KU61ZWS covered her husband, Citizen Mr Woods. IN December 2022, he drove and she was the passenger. They were on the M1 north bound carriageway about 3 miles south of Luton Airport Junction when he lost attention, collided with the barrier and did Small Damage to the Near Side. The Only Known Event Witness was Mr E.N. Stuart who was driving behind them. He stopped, presented as having Police Practice Experience, took control of events, did not make a Collision Claim, said he was travelling to Newcastle, stayed about half an hour and left. Citizen Mr Woods or Mrs Hawes, called to her son Mr Peter Hawes, who is an Insurance Actuary. A Service Call by Mr Peter Hawes got a Trivial Incident Finding + Police Boundary Finding + Attendance Refusal by Herefordshire Police. An Event Attendance by Mr Peter Hawes got an Event Photograph that shows No Damage to the Car Front. A Service Call by Citizen Mr Woods or Mrs Hawes or her son to Private Contractors got Car Removal + Disposal. The Repair Cost would have exceeded the Old Car Value. An Insurance Claim would have got disproportionate Premium Increase. They scrapped it. The Claim is for Rear Shunt Car Damage that is inconsistent No Front Car Damage.

The Unusual Claim Management is the Long Delay between the Event and the Claim Notice Telephone Call + Claim Notice Email at 10.59 on 24th November 2024 from the Claim Lawyer that got the Response Email at 12.12 on 2nd December 2024 from Citizen Mr Woods + No Other Claim Contact from the Claimant or Claim Lawyers or Insurers or Law Courts + Long Delay + On Line Civil Claim 762MC054 Judgement dated 16th July 2026 for Claimant Mr E.N. Stuart against Citizen Mr Woods + Judgement Service Notice Letter dated July 2026 from

The Fraud Evidence is the inconsistency between the No Rear Shunt Collision Evidence of Citizen Mr Woods, Mrs Hawes and her son Mr Peter Hawes that is supported by the No Front Damage Photograph and the Rear Shunt Damage Claim + Unusual Claim Management .

The Special Circumstances are Timing Coincidences of the Claim Management with the World War III Peace Plan and the Corruption Case Owner Status of Citizen Mr Woods and Mrs Hawes. In the early 1990's Technology Sales got \$5,000,000 Family Trust Capital for him + Trust Capital Theft by Californian Lawyers + House Purchase Capital Call in or about 2012 motivated Protection Fraud Service Calls by them that got Oppression Frauds by the UK against him managed by Lord Peter Mandelson. In 2003, Sex Crime Exposure by Mrs Hawes got Mass Media Coverage that was a Protection Fraud Exposure Risk for Top Network Agent Mr Mandelson and Others. It forced the Sentence Appeal by the UK + Prison Cell Sentence against Headmaster Mr Carney + 2004 Disclosure Restraint Fraud by the UK Cabinet against her. They did not know until 2021 about the Coronation Oath Enforcement Authority, Corruption Remedy Process or the Protection Fraud Network. His Management Skill and her Presentation Skill enabled Remedy Research that got Co-operation Failure Proof for the Coronation Oath Enforcement Authority against Media Managers. In 2026, Budget Fraud Cases of Citizen Mr Woods and Mrs Hawes against Top Network Agent Mr Mandelson and the UK Cabinet are excellent for servicing the Peace Plan. The Claimant and Claim Lawyer must explain the confidence to commit the Claim Fraud, whether it was Personal Business or Network Business, what influenced the Event Timing and who has Joint Liability.

The World War III Peace Plan for Democratic States

In 2004, the preparations for the European Referenda got Election Fraud Conspiracy Proof against European Leaders including Prime Minister Mr Blair. The Lawful Business of UK Citizens was an Exposure Certainty. The Election Fraud Concealment Plan used Sabotage Frauds against the Lawful Business. It got Criminal Conspiracy Proof against the European Leaders. Equity Lawyer Mr Ellis gave it to Queen Elizabeth. It is Dismissal Executions against the Judiciary by a United Parliament, Victim Identification, Case Remedies and an International Agreement for a Just World Plan. A Failure Result gets a Remedy Denial Fraud Finding against the Cabinet and Default Dismissal Penalty against the Prime Minister. It is a Remedy Co-operation Test of Parliament. A Remedy Failure by Parliament gets a Special Procedure. The Coronation Oath Enforcement Authority gets Endemic Corruption Proof against the Judiciary alone. The Crown uses it to negotiate an International Agreement for the Just World Plan. The Plan Agreement requires Sovereign States to destroy the Protection fraud Networks that manage Endemic Corruption, recover control of State Budgets, resource International War Defences and resource the Just World Plan. The Management Agreement gets Corruption remedy Test Case Status for the UK, Test Manager Status for the Coronation Oath Enforcement Authority, Interested Party Status for the Peace Plan Signatories and the Common Law for the Just World Plan. The Remedy Agreement gets Remedy Enforcement against Fraud Profiteers and Penal Enforcement against Political Leaders. The Delivery Agreement gets Delivery Commitments some of which are conditional. The Publicity Agreement gets Whole Plan Secrecy and Mass Publicity for Plan Stage Successes until there are enough for Whole Plan Publicity. Commitment Deliveries by Peace Plan States finance Scandal Remedy Budgets needed for Corruption Exposure. It increases the MP Retirement Rate and enables the General Election to get a Power Transfer to a New Governing Majority. Peace Plan States use Repeat Cycles of Corruption Exposure until it gets Remedy Delivery by a Governing Majority, and a Remedy Precedent for the Just World Plan. In 2021, a Parliament Unity Failure created the need for the Special Procedure.

In 2023, King Charles negotiated the World War III Peace Plan for Democratic States. It got Remedy Budgets for the Post Office Scandal + Contaminated Blood Scandal. It enabled the 2024 General Election to get a Governing Majority Transfer from Network Agents that used the Conservative Party to Network Agents that used the Labour Party.

The 2024 Parliament Session Grant required Remedy Delivery starting with 20,000 Political Prisoner Releases. The UK Cabinet dare not make any Political Prisoner Admissions because Prime Minister Sir Keir Starmer had procured thousands of them when he was Director of Public Prosecutions. The 3,500 Guilty Prisoner Releases for the Overcrowding Reason was a Session Grant Breach. It got

The Peace Plan States used World War III to extort the 3.5% Defence Budget Commitment from the UK Cabinet that needed Total Termination of Budget Frauds. They used the Child Prostitution Scandal to extort the Remedy Delivery Commitment from the UK Cabinet. It was Dismissal Executions on 14th July 2025 against the Judiciary and the Trial Listing on 17th July 2025 of Framing Fraud 2023 0058 for Victim Identification + Case Remedies. They were Commitment Frauds. They made Lord Peter Mandelson the Remedy Sabotage Manager and gave him the office of UK Ambassador to the USA. He negotiated the Treason Deal. It got Big Bribes for USA President Mr Trump, Epstein File Concealment Frauds for the UK Cabinet, Defence Sabotage Frauds for Russia against Ukraine, Western Europe and NATO. The Peace Plan States managed Treason Deal Failures and used the 3.5 Defence Budget Failure Scandal + Epstein Scandal + Mandelson Scandal + Starmer Scandal + Leadership Contest Denial Fraud Scandal that got the Forced UK Premier Appointment Fraud for Mr Burnham with Protection Fraud Conditions for Mandelson + Starmer + Trump + Top Financiers. The Budget Fraud Claims will get a Forced Choice between Protection Fraud Puppet Status or Peace Plan Puppet Status.
