Polite Request + Best Advice that the Crown and Parliament Session discover whether NHS Patients 6328556020 is getting a Standard Transplant Service, or a Special Transplant Service. REASONS:

1. The Transplant Assessment ignored the Poison Damage done by an Attempted Murder.
2. The Kidney Offer Telephone Call at 03.13 on 21st August 2026 creates the need:
 - 2.1. To discover whether a Standard Service ignores the Poison Damage, or a Special Service used Poison Damage Blood Tests as a Risk Control before the Kidney Offer.
 - 2.2. To discover what impact, if any, the NHS Patients 6328556020 + 6225834931 Budget Fraud Enquiries + Patient 6225834931 Review Appointment on 19th August 2026 + Event Report
 - 2.3. To discover whether the True Purpose of the Kidney Offer was to take3 the Equity Lawyer out of circulation and deny his service for the Budget Fraud Tests of Prime Minister Mr Burnham

Kidney Transplant Offer + Reasoned Refusal Report

Confidentiality Waiver + Grateful Thanks for the Kidney Offer Telephone Call at 03.13 on 21st August 2026 by Royal London Hospital using a Withheld Number to NHS Patients 6328556020 Mr Edward Ellis

Refusal Reasons:

1. It was a Middle Quality Offer – [Long Term Diabetic + Smoker + Late 50's + creatinine 115 against optimum 80].
2. The Patient is Equity Lawyer Mr Ellis. He is coping well with Dialysis Treatment. He had a Lucky Recovery from Terminal Decline. He has Improving Physical Condition.
 - 2.1. He provided Corruption Investigation Services that enabled the Coronation Oath Enforcement Authority to get a Forced Resignation from Prime Minister Mrs May + Forced General Election on 12th December 2019.
 - 2.2. Prime Minister Mr Johnson won. He wanted to stop the Equity Lawyer getting Corruption Proof against him. He issued a Poison Kill Order. Secret Service Officers executed it using a Poisoned Tea on 18, 19 or 20 December 20219 at a Corruption Victims Meeting in a cafe across the road from the Royal Courts of Justice. The 1st Crisis was in Week 6 – 7. The body needed to excrete Big Molecules using Sweat Gland Ruptures. The Patient survived by Repeat Breaking of Rupture Scabs, enabling reuse of Damage Glands and thereby saved the rest of the skin and the life. The 2nd Crisis was Reducing Blood Pressure. The choice for Medical Practitioners was Notice Nothing + Do Nothing or Mental Health frauds to deprive the Victim of Legal Capacity for Remedy Action, or Effective Treatment that incur Life Ruin Penalties. No one provided Effective Treatment. It forced Self Remedies: Locate Poison Deposit + Break Skin + Balanced Judgment on Poison Removal with Flesh Damage Limits.
 - 2.3. The Medical Records are Murder Conspiracy Proof + Murder Concealment Fraud Proof + Murder Survival Proof. They are Reducing Blood Pressure Proof + Blood Pressure Remedy Denial Proof from the start of Dialysis Treatment in April 2020 until Total Collapse on 6th January 2026 onto an Outpatient's Dialysis Bed. It got Immediate Treatment + Inpatient Admission + Day 4 Release with Good Blood Pressure. The Terminal Decline denied Body Repair and released Feel Good Chemicals for a Swan Song Period.
 - 2.4. The Lucky Recovery got Good Blood Pressure + Creeping Body Repair at the cost of Chronic Tiredness.
 - 2.5. Recovery Day 138 got the Kidney Offer Day. There was a Dramatic Improvement in Body Repair and Dramatic Reduction in the need for Self-Treatment.
 - 2.6. The Patient hopes the Recovery Process will end the need for Self-Treatment and improve Transplant Fitness.
3. The Patient continues to provide Corruption Investigation Services for the Coronation Oath Enforcement Authority. In 2023, he got Endemic Corruption Proof against the Judiciary. King Charles used it to negotiate the World War III Peace Plan for Democratic States. The December G7 Summit got Agreement Signatures. It got Corruption Remedy Test Cases Status for the UK, Test Manager Status for the Coronation Oath Enforcement Authority, Interested Party Status for the Peace Plan States and the Common Law for Just World Order. Remedy Enforcement by Japan and the USA against Fraud Profiteers financed the Remedy Budgets for the Post Office Scandal + Contaminated Blood Scandal. It enabled the 2024 General Election to get a Power Transfer from Endemic Corruption Managers using the Conservative Party to Endemic Corruption Managers using the Labour Party. The Peace Plan States used the Imprisonment Fraud Scandal + Child Prostitution Scandal + Treason Deal Scandal + Epstein Scandal + Mandelson Scandal + Starmer Scandal + Iran War Frauds Scandal + Leadership Contest Denial Fraud Scandal + UK Premiership Appointment Fraud Scandal. They need Budget Fraud Test Cases in the 2026 Summer Recess to get a Forced Choice from Prime Minister Mr Burnham for the Peace Plan or Budget Fraud Profits. The Test Result, whatever it is, will service the Treason Impeachment of USA President Mr Trump.
