

Application: Equity Lawyer Mr Edward Ellis      Respondent: State + UK Cabinet

Grounds: Fraudulent Breaches of Natural Justice + Human Rights + Overriding Justice Objective. Remedy Proposals:

1. World War III Peace Plan Finding + Corruption Remedy Test Case Status for the UK Finding + Test Manager Status for the Coronation Oath Enforcement Authority Finding + Conflicted Interest Finding + Conflict Disqualification Finding + Remedy Only Jurisdiction Limit Finding + Justice Process Contempt Investigation Order + Investigation Resource Reference to Parliament for All Citizens and the Peace Plan States against the State, Profession Authorities, Law Courts and Cabinet
2. Pending Remedies Enforcement Stay Protection for the Equity Lawyer and All Citizens against the State
3. Press Harassment Claim Relevant Case Finding for the Equity Lawyer against the State
4. Protection Notice Order for the Press Harassment Claimants against the State

REASONS:

1. The Coronation Oath Enforcement Authority manages the Profession Authority responsibilities of Parliament.
2. Citizen Ms Michelle Davies was the Appellant in Osteopath Misdescription Crime 2022 0062 Appeal + Council Tax Statutory Demand 2026 00112 Revocation Refusal Appeal. Judge Mr Salmon was the 2022 0062 Plea Hearing Judge and the 2026 00112 Appeal Judge.
3. Routine Bribery managed by Lord Peter Mandelson for the Pharmaceutical Industry bought Profession Governance Frauds by the General Osteopathic Council. Special Bribery managed by him for them bought the Osteopath Misdescription Criminal Trial Frauds by the Worcester Judges. The Coronation Oath Enforcement Authority manage the Profession Authority responsibilities of Parliament. Equity Lawyer Mr Ellis serviced a Bribery Investigation for them. He attended the Plea Hearing and Re-Trial as Defence Assistant and Jurisdiction Witness. The 2022 0062 Audio Records are Trial Fraud Conspiracy Proof against the Plea Hearing Judge and Re-Trial Judges. The Retrial Judges used Court Officers and Jurisdiction Trial Pretence Frauds + Jurisdiction Witness Status + Jurisdiction Witness Exclusion Practice Pretence Frauds for a Court Room Exclusion Fraud against the Equity Lawyer. He used a separate entrance to the Public Gallery. They Court Officers used an Assault Complaint Fraud to get 22CA1074323 Investigation + Public Gallery Criminal Trespass + Arrest Fraud + Custody Fraud by West Mercia Police for the Public Gallery Exclusion Fraud against the Equity Lawyer. Trial Fraud Conspiracy Allegations + Audio Record Production Demands by the Equity Lawyer got Audio Record Exclusion Frauds that are Investigation Fraud Proof + Charge Fraud Proof against West Mercia Police. The 2022 0062 Re-Trial Audio Record is Jurisdiction Trial Denial Fraud + Liability Re-Trial Fraud Proof. The 22CA1074323 Defence + Crown Court Audio Record Production Demand + Bail Surrender Refusal Notice from the Equity Lawyer got Confidence Collapses by Court Officers and Judges + Case Closure Frauds by Worcester Magistrates.
4. All of it added to Endemic Corruption Proof against the Judiciary. King Charles used it to negotiate the World War III Peace Plan for Democratic States. The December G7 Summit got Agreement Signatures. The Peace Agreement requires Sovereign States to destroy the Protection Fraud Networks that manage Endemic Corruption, recovery control of State Budgets, resource World War III Defences and resource a Just World Order. The Management Agreement got Remedy Test Case Status for the UK, Test Manager Status for the Coronation Oath Enforcement Authority, Interested Party Status for Peace Plan States and the Common Law for a Just World Order.
5. Remedy Enforcement by Japan and the USA against Fraud Profiteers financed the Remedy Budgets for the Post Office Scandal and Contaminated Blood Scandal. Corruption Exposure enabled the 2024 General Election to get a Power Transfer from Network Agents using the Conservative Party to Network Agents using the Labour Party. The 2024 Parliament Session Grant contained Corruption Remedy Conditions. They required 20,000 Imprisonment Fraud Releases + Remedy Delivery: Dismissal Executions against the Judiciary + Victim Identification and Case Remedies. The Network Agents had procured thousands of the Imprisonment Frauds. Prime Minister Sir Keir Starmer had done so as Director of Public Prosecutions. 3,500 Guilty Prisoner Releases for the Overcrowding Reason was a Session Grant Breach. It got a Fraud Finding against the Cabinet and Dismissal Default Penalty against Prime Minister Sir Keir Starmer. Peace Plan Leaders serviced it. They extorted the 3.5% Defence Budget Commitment from the UK Cabinet. It needed Totao Termination of Budget Frauds. In January 2025, they used the Child Prostitution Scandal to get Remedy Delivery Commitments for July 2025. They used the Treason Deal Scandal + Remedy Delivery Failure Scandal + Epstein Scandal + Mandelson Scandal + Starmer Scandal + Leadership Contest Denial Fraud Scandal. The 41CT1345226 Framing Fraud Investigation motivated the 22CA1074323 Bench Warrant Forgery Frauds against the Equity Lawyer. The Network tried to defend itself with the UK Premiership Appointment Fraud for Mr Burnham with Protection Fraud Conditions for Mandelson + Starmer + Trump + Others. It got a Confidence Collapse + 2026 00112 Bribery Admission by Judge Mr Salmon.
6. In the 2026 Summer Recess, Budget Fraud Test Cases will force Prime Minister Mr Burnham to choose the Peace Plan or Budget Fraud Profits. In either event, UK Corruption Proof will service the Treason Impeachment of Renegade USA President Mr Trump. The Press Harassment Claim Dismissal + Costs Order are Crime Proceeds of Conflict Jurisdiction Qualification Frauds by the Judiciary. The Peace Plan can use it. *[870 words excluding italics]*
