5. In 2021, Remedy Failures by the Cabinet and Parliament created the need for International Support. It needed Endemic Corruption Proof against the Judiciary. It needed Bribery Management by a Top Network Agent for Fraud Profiteers that got State Budget Frauds + Law Court Frauds + Parliament Protection Frauds.
6. Bribery by the Pharmaceutical Industry bought Market Frauds for Drug Treatment against Other Treatment. One was creation of the General Osteopathic Council to manage Profession Governance Frauds against Registered Osteopaths. Routine Bribery got the Profession Authority Frauds. Special Bribery got Law Court Frauds. In 2000, Fraud Complaints in more than 200 Constituencies got a Corruption Debate + Investigation Commitment + Pending Investigation Adjournment + Bribery of Prime Minister Mr Blair + Investigation Denial Frauds + Remedy Denial Frauds by Parliament that were Protection Frauds for the General Osteopathic Council that continue.
7. A Patient Satisfaction Internet Publicity Prohibitions was a Market Fraud for Competitors against Registered Osteopaths. Fraud Complaints by Osteopath Ms Davies motivated Profession Governance Frauds 2855 839 + Osteopath Misdescription 22 00069636 Trial + 2022 0062 Appeal Re-Trial by the General Osteopathic Council against her. She discovered the Coronation Oath Enforcement Authority, gave the Corruption Remedy Process use of her cases and got Citizen Status. She was on an Emotionally Exhausting Learning Curve. Case Management Services by Equity Lawyer Mr Ellis for the Coronation Oath Enforcement Authority got Special Bribery Proof against Lord Peter Mandelson and the Worcester Judges. It was part of the Endemic Corruption Proof Set.
8. King Charles used it to negotiate the World War III Peace Agreement for Democratic States. The December G7 Summit got Agreement Signatures.
