Do you admit deny or require proof that:

1. The Coronation Oath is for Equity Governance using the Common Law?
2. The Police Advisory Notice to Suspects contains the words ‘Perverting the Course of Justice’ and ‘Under the Common Law, it is an offence to conspire, act or embark upon a course of conduct which has a tendency to, and is intended to pervert the course of public justice. 45. Bribery Management by Lord Mandelson for the General Osteopathic Council and Pharmaceutical Industry got Profession Governance Frauds + Osteopath Misdescription 22 00069636 Trial Frauds and 2022 0062 Appeal Frauds against Citizen Ms Davies by Worcester Judges
