

Remedy Co-operation Test Notice:

1. The World War III Peace Plan got Corruption Remedy Test Case Status for the UK, Test Manager Status for the Coronation Oath Enforcement Authority, Interested Party Status for the Peace Plan States and the Common Law for the Just World Order.
2. The Common Law uses a Validation Process for Rights Definition and Rights Enforcement. It needs identifies and eliminates wrong to discover right. It grades wrong by the proportion of the population it can harm. It starts invalidates anything that risks a Relation Breakdown between the People and God, then International War, then Civil War, then Local Riot, then a Brawl. It discovers the Potentially Valid Options Set. The Validation Process grades the options in the Potential Set, eliminates the worse. And repeats the process until there is a set of one, or more than one with equal validity, and selects it or one for the Rights Declaration.
3. The Test Case is on the Rights Enforcement Stage. It needs to manage Corruption Remedies in Parliament, then the Law Courts and then the State.
4. Meanwhile, the Equity Lawyer manages Integrity Tests that identify Remedy Volunteers in the State and Law Courts. On 12th October 2009, issue of the Protection Fraud Claim CO 2009 11860 of Citizen Mr Hoath v Prime Minister + Secret Service, and Personal Service that day at 5 Buckingham Palace Gate, London got a Remedy Co-operation from the Secret Service. Since then, the UK has had a Schizophrenic Secret Service. Part of it provided Protection Fraud Services for Renegade Cabinet Officers and another part provided Remedy Services for the Crown. They turned some of the Protection Fraud Network Agents into Remedy Agents. Some were Sleepers and others were Active. Most of the Judiciary have no idea who among the Court Officers and Fellow Judges will give Fraud Evidence against them.
5. Voluntary Co-operators will get Proportionate Benefits. Many of them will cease to be Deterrent Precedent Targets. Court Motion Findings + Remedy Orders will be a start. A lot more can be done.
