1. The Western European Dictator Governance Plan vested Dictator Powers in the Cabinet. In every Member State of the European Union the Politicians lost control to Crime Partnerships of State Officers and Law Court Judges. They developed Protection Fraud Networks to provide Support Services and manage Co-ordinated Corruption.
2. The UK Network co-ordinated the Local Businesses that managed Tobacco Duty Evasion + Drug Crimes into a National Business. The Network existed to make money. The Crime Business Expansion Plan was inevitable. It needed: Management Research to discover what was needed for Industrial Scale Protection Frauds by Law Courts + Cabinet Control + a Profit Share Limit for Network Puppet Masters against Cabinet Officer Puppets
3. The New Businesses were Market Frauds for Insurers and Bankers against Customers + Market Frauds for Drug Treatment against Other Treatment. It included creation of Profession Authorities to manage Governance Frauds against Regulated Practitioners who did not use Drug Treatment + Performance Enhancing Drugs for Sport Professional and Fitness Fanatics. It needed Discredit Frauds against Honest Competitors who had Influencer Status + Land Frauds for Big Owners against Small Businesses + Land Thefts for Network Agents against the State + a Blackmail Business using Entrapment Frauds and Framing Frauds to get Blackmail Fraud Profits + Family Sabotage Frauds + Child Thefts to get Big Budgets + Budget Fraud Profits and Expatriation Frauds to get Money Laundering Services from Sovereign States + Anything else that made money
4. In 1997, the general Election got a Landslide Majority for Prime Minister Mr Blair and the 1st Cabinet Office for Mr Peter Mandelson. The Predictable Greed of Prime Minister Mr Blair denied Cabinet Control for the Network. Mr Mandelson was Marketing Manager for Policy Waiver Frauds for Prime Minister Mr Blair. Mr Mandelson used Cabinet Office to manage the Performance Enhancing Drugs. The Finance Disclosure Denial Fraud Scandal got the 1st Forced Dismissal. Mr Mandelson remained Policy Fraud Marketing Manager and therefore had Cabinet Influence. The 2001 General Election got the 2nd Cabinet Office for Mr Mandelson. The Passport Scandal got the 2nd Forced Dismissal.
5. In 2004, the preparations for the European Referenda got Election Fraud Conspiracy Proof against European Leaders including Prime Minister Mr Blair. The Election Fraud Concealment Plan got Criminal Conspiracy Proof against them. The 1st Effort exposed the Protection Fraud Network. The 2nd Effort got a Profit Share for Prime Minister Mr Blair and Cabinet Control for the Network, but the Cabinet Share Limit prevented using it for the remaining Business Expansion Plans. Equity Lawyer Mr Ellis gave the Criminal Conspiracy Proof to Queen Elizabeth. She used it to revive active service of the Parliament Sessions Court and start a Corruption Remedy Process. In 2006, Corruption Proof enabled the Forced 10 Months Retirement Notice from Prime Minister Mr Blair. The Leadership Contest discovered the Appointment Fraud for Sole Candidate Mr Brown on condition he provide Protection Frauds for Mr Blair and give Cabinet Office to Mr Mandelson. None of the Local Parties wanted him as Constituency MP. He needed a Peerage Fraud for a Cabinet Office Qualification. He used it to manage the Land Frauds Expansion Plan for Big Owners against Small Business. In 2010 the General Election got the Coalition Government. The Coronation Oath Enforcement Authority got Remedy Co-operation from Prime Minister Mr Cameron, Deputy Prime Minister Mr Clegg and Opposition Leader Mr Miliband. Lord Mandelson had enough Cabinet Influence to continue the Established Business but not for New Business Expansion Plans until 2016 when the Prime Minister's Office passed from Mr Cameron to Mrs May.
6. In 2021, Protection Frauds by the Cabinet and Parliament created the need to get International Support for Corruption Remedies. It needed Endemic Corruption Proof against the Judiciary. In 2023, Bribery managed by Lord Mandelson got the Osteopath Misdescription 22 00069636 Trial Frauds and 2022 0062 Appeal Frauds against Citizen Ms Davies by Worcester Judges against Citizen Ms Davies. They used the Framing Fraud 22CA1074323 to remove the Equity Lawyer from the Public Gallery.
7. King Charles used the Endemic Corruption Proof against the Judiciary to get the World War III Peace Plan for Democratic States.
8. **Worcester Judges can use an Interim Case Statement to say they need needed the Peace Plan States to manage Safe Conditions for a Full Explanation and use the Final Case Statement to say Duress Conditions got the Bribe Acceptance.**
