Political Neutrality Commitment

The Common Law governs the World War III Peace Plan. The UK Coronation Oath Enforcement Authority is the Corruption Remedy Test Case Manager. They use the Corruption Remedy Proof Standard. It is Official Records that are Justice Proof for Honourable Officers or Guilt Proof against Corrupt Officers and Credibility Irrelevance Proof for the Victim. The Test Case is a Pincer Operation. The Crown and Parliament Session Court work down through Parliament. They use Corruption Remedy Standard Proof got by the Citizen and Equity Lawyer working up through the State, Profession Authorities and Law Courts. The Common Law uses a Credible Neutrality Qualification for Conflict Jurisdiction Offices. The Coronation Oath Enforcement Authority is a set of Conflict Jurisdictions manage the Parliament Session Powers of the Crown. The Citizen is the Aggrieved Party. The Office Qualification is a Confidentiality Waiver + Privilege Waiver + Priority Waiver that enables use of the truth, whole truth and nothing but the truth about the Case Facts for Integrity Tests of the Authorities that get Proof Sets that meet the Corruption Remedy Standard. The Equity Lawyer is the Integrity Test Case Manager. The Office Qualification is the competence, courage and generosity. The Crown is the Prosecutor. The Office Qualification is Lawful Succession. It is a Risk Control against Succession Wars. The Office Powers are Trial Orders for the Parliament Sessions Court of Corruption Cases against the State and Unfitness Cases against Officers and Authorities. The Lord Archbishops are the Court Lawyers, one for the Trial Court and the other for the Appeal Court. The 24 Lord Bishops are the Jury Panel. They provide up to 12 Trial Jurors and up to 12 others as Appeal Jurors. When they are busy, they split into 2 Trial Juries of up to 8, and 1 Appeal Jury of up to 8. The Corruption Remedy Proof Standard eliminates the need for Witness Attendances, Credibility Findings and Personal Case Presentation. It enables Trial Orders of the Crown to get Trial Verdicts in 7 days and Appeal Decisions in 10 days.

All Processes are Fitness Investigations of Office Holders or Office Replacements. The Common Law uses a Secrecy Presumption for Investigators pending Rebuttal Proof Positive. It governs everything done by the Crown and Parliament Sessions Court. It invalidates the Open Process Presumption that requires a Public Gallery for the Citizen to observe the Adjudication Process. A Reverse Presumption requires Open Process Management by the Citizen and Equity Lawyer. It is subject to Rebuttal Proof Positive that are governed by the need to reconcile the Case Facts with the Justice Priority.

Power Concentrations create Vested Interests that resist

Change Management. The Peace Plan States have Constitutional Legacies that enabled Power Concentrations in Commercial Managers. The reason is that Commercial Managers resourced the Power Struggle Victors who defined the Constitutional Balance. The UK has a Schizophrenic Constitutional Balance. There is an Inherent Conflict between the Cultural Aspiration and Political Reality. Saxon England vested Accountability Power in the Citizen. It was not perfect. It was better than anywhere else. It had a Relatively Free Market and a Successful Economy. The Norman Conquest imposed Dictator Governance. It was a Military Success and Plunder Failure. The Absolute Priority was Status Investment. It redirected talent from creation of Portable Wealth into Immovable Structures: castles + cathedrals. The Domesday Survey was the Plunder Generation acknowledging the Plunder Failure by asking where the money is. They were the Vested Interest. They could not admit Problem Liability. Nor could William II. His younger brother, Henry, did. The coup replaced William with Henry. He used a monk to write a book that was an Invasion Wrong Admission. Vested Interests prevented Remedy Management until Crisis Conditions got a series of Partial Remedies. In the 17th century the 2nd Civil War Risk motivated Advice Requests by the Establishment got Glorious Revolution Management by Equity Lawyers. It got a Forced Evacuation by King James II used it for an Abdication Finding + Lawful Succession Finding conditional upon a Parliament Session Limit for Crown Powers and creation of the Coronation Oath Enforcement Authority to manage Error Risk Controls. It got Vested Interest Status for the Citizen subject to a Resource Dependency on Generous Individuals. Crisis Conditions found Generous Individuals and Partial Remedies. The Present Crisis needs Complete Remedies. It needs Honest Admissions + Genuine Apologies + Remedy Commitments
