The Adjourned Interview Proposals dated 11<sup>th</sup> September 2025 of Citizens Mr Nkrumah and Mr Coyle give Conflict Disqualification Notices against the Case Officers and Hertfordshire Police.

On 28<sup>th</sup> August 2026, Complaint Frauds by Stevenage Magistrates Security Guards got Hertfordshire Police Cases [418261826 + 418267026] + 418267126 Arrest Frauds against Citizen Mr Nkrumah and Citizen Mr Coyle + Case Separation Frauds + Custody Frauds + Bail Condition Frauds. They include an Area Exclusion Prohibition defined by a Missing Map. The Map provided was the route from the Police Station to the Railway Station. The Surrender Date is 30<sup>th</sup> September 2026 with Separate Times: [08.30 for 418261826 + 418267026 and 13.00 for 418267126.] + Pre Charge Engagement Notice Frauds + Disclosure Frauds.

Records Demands by Citizen Mr Nkrumah got the Self-Assessment Record + Assessment Records + Custody Record. A Quadruple Disadvantage prevented Citizen Mr Coyle making Record Fraud Demands. The 1<sup>st</sup> Disadvantage was that Severe Dyslexia, and a Speech Defect, are a Communications Handicap. The 2<sup>nd</sup> Disadvantage was that a Past Events Repetition Risk had effect as Intimation Frauds against him. Blackmail Frauds by his father got a Mental Illness Diagnosis Fraud by the Family GP that got Custody Fraud + Forced Medication Frauds + Family Sabotage Frauds against him. The Fraud Motive was that his father feared that he was a Crime Exposure Risk. He knew his father was Chronically Immature and Sexually Perverted. He did not know about his Criminal Activity. The 3<sup>rd</sup> Disadvantage was that Hertfordshire Police had managed 3 Framing Frauds against him. The 4<sup>th</sup> Disadvantage was that he has Personal Knowledge of Case Sabotage Frauds by Regulated Lawyers against Clients. The 4 Disadvantages had effect as Defence Sabotage Frauds. The Assessment Officer 418558 Cardines did not discover any of the 4 Disadvantages, each of which made him a Vulnerable Individuals.

The Counter Complaints got Process Denial Fraud Proof. The Response Difference got by the Complaint and Counter Complaint is Bias Fraud Proof for the Citizens against the State.

The Complaint Defence Case and the Counter Complaint of Citizen Mr Nkrumah against the Security Guards are supported by the Event Videos + Witness Testimony of Citizen Mr Coyle and Equity Lawyer Mr Ellis.

Mobile Phone Event Videoing by Citizen Mr Coyle got Video Complaint Threats by the Magistrates Court Security Guards who are the Complainants. It is Witness Intimidation Evidence against them. Threatening Behaviour Complaint Frauds by the Security Guards against Citizen Mr Coyle The Counter Complaint of

Equity Lawyer Mr Ellis does not have the same Videoing Expertise. He observed events. A Smoker Group who stood outside the building across the road. They showed Intense Interest in the events. He spoke to them. They denied having Witness Status. He did not. A Witness Evidence Offer by the Equity Lawyer got an Identity Request by a Police Officers, Identity Disclosure by the Equity Lawyer, Identity Check by Hertfordshire Police that discovered the 2<sup>nd</sup> 22CA1074323 Forged Bench Warrant Arrest Fraud. The 2<sup>nd</sup> Bench Warrant Arrest Fraud got the Arrest Validity Investigation Test by the Equity Layer using notice of the Fraud Appeal to Chelmsford Crown Court against the 1<sup>st</sup> Forged Bench Warrant Authority Arrest Fraud. The Arrest Officer ignored it.

The Validation Investigation Denial Fraud got Vulnerable Individual Status for the Equity Lawyer. He could not risk Repeat Health Sabotage Frauds to those committed by West Mercia Police in 2023. It was an Operation Constraint for the Validity Investigation Test. He seized every opportunity to explain and everything that got a Split Judiciary. Many of them want Safe Conditions to admit Court Frauds and make Blackmail Complaints that Implied Threats and Express Threats got Forced Bribe Acceptance by them. He has End Stage Kidney Failure. He starts to die three times a week and is saved by Dialysis Treatment. He needed to avoid use of the Custody Fraud + Remand Fraud for Dialysis Treatment Sabotage Fraud by preventing him from arriving at Broomfield Hospital before 07.00 the next morning. In 2023, that is what West Mercia Police did. Osteopath Misdescription 2022 00069636 Trial Frauds and 2022 0062 Appeal Frauds against Citizen Ms Davies by the General Osteopathic Council and Worcester Judges against Citizen Ms Davies. They are the Crime Proceeds of Bribery Management by Lord Peter Mandelson for the Pharmaceutical Industry. The Crown Court Appeal Judges needed to avoid a Trial Report by the Equity Lawyer to the Crown and Parliament Sessions Court. They used Court Officers for a Court Room Exclusion Fraud. The Public Gallery had a Separate Entrance. The Court Room was the Crime Scene, and the Audio Record was an Event Record of both the Court Room Exclusion Fraud and the Public Gallery Clearance Fraud. It used Court Officers for an Assault Complaint Fraud that got West Mercia Police Case 22CA1074323 + Arrest + Arrest Validation Investigation Denial Fraud + Event Audio Record Exclusion Frauds + Custody Video Audio Record Exclusion Frauds + Recorded Interview Exclusion Fraud + Complaint Perjury + Other Event Witness Evidence Exclusion Frauds + Charge Fraud + Bail Conditions Fraud + Release Delay Fraud until the

The Equity Lawyer needed to stay awake in case an opportunity arose. He was lucky. A Bus Manager had a relative with Kidney Failure. He gave him someone else seat on a bus to Luton Airport. It enabled him to get another bus to Chelmsford. The Medical Records will evidence a Short Session and the Treatment Time Loss. If he had not arrived in time, there might have been a Treatment Delay until Monday or Tuesday.

The 22CA1074323 Defence + Contempt Remedy Application + Bail Surrender Refusal Notice dated 4<sup>th</sup> April 2023 was sent to the West Mercia Police + Essex Chief Constable + Metropolitan Police Commissioner + Worcester Chief Crown Prosecutor + Magistrates Court. It got a Forced Confidence Collapse + Forced Case Closure Fraud. Case 22CA1074323 and much more was an Endemic Corruption Proof against the Judiciary. King Charles used it to negotiate the World War III Peace Agreement for Democratic States. The Japan Prime Minister and USA President Mr Biden used it for Remedy Enforcement against Fraud Profiteers that financed the Remedy Budget for the Post Office Scandal and Contaminated Blood Scandal. They got the Costs Plunder Fraud Conspiracy Proof against the Expert Witnesses and Case Lawyers of the Post Office and Health Ministry. It was yet another Corruption Scandal. Corruption Exposure got an increase in the MP Retirement Rate, an Incredible Choice and Split Conservative Values Majority Vote that enabled a Minority Vote to get a Landslide Majority for Prime Minister Sir Keir Starmer. It was a Forced Power Transfer from Protection Fraud Network Agents who used the Conservative Party to Protection Fraud Network Agents that used the Labour Party. The 2024 Parliament Session Agreement started the Forced Power Transfer against them. It is Work In Progress. It used the Imprisonment Fraud Scandal + Child Cabinet Bribery Scandal + Sex Crime Investigation Denial Fraud Scandal + Child Prostitution Scandal + Treason Deal Scandal + Remedy Denial Fraud Scandal + Epstein Scandal + Mandelson Scandal + Starmer Scandal + Leadership Contest Denial Fraud Scandal + UK Premier Appointment Fraud for Mr Burnham Scandal + 3.5% Defence Budget Failure Scandal. The Peace Plan States needs a Test Case that uses State Frauds and Court Frauds for a Budget Fraud Investigation of Top State Officers and Law Court Judges.

The Coronation Oath Enforcement Authority managed a Corruption Remedy Process to get the Endemic Corruption Proof against the Judiciary and World War II Peace Agreement. It used the Corruption Remedy Process to get the Scandal Series. All stages motivated Framing Frauds against anyone who was an Exposure Risk. Citizen Mr Coyle fled Northern Ireland and helped Equity Lawyer provide Support Services for the Corruption Remedy Process. It motivated a Drug Crime Framing Fraud against Citizen Mr Coyle. It needed a Sighting Report of Citizen Mr Coyle with a Drug Dealer. Building Business Pretence Frauds an Albanian Drug Dealer that got a Metting Attendance by Citizen Mr Coyle for the Sighting Report. A Building Business Pretence Fraud Report by Citizen Mr Coyle enabled production of a Suspicious Circumstance Statement by the Equity Lawyer for Citizen Mr Coyle that got a Confidence Collapse + Framing Fraud Service Refusal by the Metropolitan Police. The Framing Fraud Conspirators procured Framing Fraud Services from Hertfordshire Police: Uninsured Driving Framing Fraud 41CT1201622 + Stop Failure + Driver Identification Failure Framing Fraud 41CT1345226 + Traffic Light Direction 1.7 Second Breach Framing Fraud 0413050854905220. The Equity Lawyer used Case 41CT1201622 for a Framing Fraud Investigation. A Sunday Meeting Offer for Sunday 15<sup>th</sup> March 2026 + Chelmsford Location were a Risk Control against Dialysis Treatment Sabotage Fraud preventing him being at Broomfield Hospital at 07.00 on Tuesday

The Assessment Process got Vulnerability Record Fraud Proof against the Assessment Officer.
