The Budget Fraud Lead Case is 22CA1074323 pending issue of the High Court Claim. REASON:

1. The Fraud Appeal filed on 20th April 2026 got Pending Adjudication Enforcement Stay Protection for the Equity Lawyer from the Superior Jurisdiction of the Crown Court against the Inferior Jurisdictions of the State and Magistrates Court.
2. The Alleged Bench Warrant in March 2026 by Worcester Magistrates was an Order Breach Contempt Fraud and incurred Aggravated Liability because All Responsible Individuals were Justice Offices with Special Knowledge
3. The Warrant Enforcement on 28th August 2026 was an Order Breach Contempt Fraud and incurred Aggravated Liability from the time the first officer had the Protection Notice because All Responsible Individuals were Justice Offices with Special Knowledge
4. The Alleged Case Transfers on 28th September 2028 from Worcester to Hatfield and from Hatfield to Chelmsford and the Trial Orders of Hatfield were Aggravated Liability Events.
5. Framing Fraud 22CA1074323 against Equity Lawyer Mr Ellis was part of the Set Up Conditions for the Framing Frauds 41345226 + 418261826 + 418267026 + 418267126 against Citizen Mr Coyle and Citizen Mr Nkrumah.
6. The Lead Case + Connected Cases enable Budget Fraud Enquiries at every stage of every process
