

Witness Intimidation Statement of Citizen Mr Patrick Coyle

1. The Witness Intimidation Complaint Fraud. On 28th August 2026, Mobile Videoing by me of the Physical Violent by Stevenage Magistrates Security Officers against Citizen Mr Nkrumah got Threatening Behaviour by them against me. Continued Mobile Videoing by me motivated a Threatening Behaviour Complaint Fraud by them that got Investigation 418267126 + Arrest Fraud + Custody Fraud + Bail Fraud.
2. The Bail Papers include:
 - 2.1. The Police Advisory Notice to Suspects. It contains the words 'Perverting the Course of Justice' and 'Under the Common Law, it is an offence to conspire, act or embark upon a course of conduct which has a tendency to, and is intended to pervert the course of public justice. Some of the ways in where conduct is capable of amounting to this offence is by making false allegations, perjury, concealing offences, obstructing the police, assisting others to evade arrest, failing to prosecute, interfering with witnesses/evidence/jurors, and public cation of matters calculated to prejudice a fair trial.'?
 - 2.2. The Pre Charge Engagement Notice. It contains the words
 - 2.2.1. 'in particular you are prepared to provide consent for the police to obtain any part of your medical history which may influence the outcome of the case.'
 - 2.2.2. Please provide details of any witness you would like spoken to, including sufficient information to enable the police to contact the witness(es) and/or the details of any person you may be responsible for this offence.'
3. The 1st Witness Intimidation Counter Complaint on 28th August 2026 by me got Process Denial Fraud Proof that is Bias Fraud Proof for me against Hertfordshire Police.
4. The entire Case 418267126 Process is a Common Law Justice Perversion Crime against me.
 - 4.1. I am not prepared to give Medical Records Access Consent because they are the Crime Proceeds of a Framing Fraud against me. I knew my father was Chronically Immature and a Sex Obsessive. I did not know he managed Paedophile Entrapment Frauds and Paedophile Framing Frauds that got Blackmail Evidence for the Northern Ireland Protection Fraud Network. He feared Corruption Exposure by me. He took Pre-emptive Action against me. Blackmail Frauds by him got a Mental Illness Diagnosis Fraud from the Family GP against me + Arrest Fraud + Custody Fraud + Forced Medication Frauds. Later, there was a Profession Unfitness Findings got a Practice Disqualification against the GP. It should have forced Case Reviews. It did not in my case.
 - 4.2. Case Witness self-identification by Equity Lawyer Mr Ellis got the 2nd Bench Warrant Forgery 22CA1074323 Arrest Fraud against him. Crown Court Pending Fraud Appeal Enforcement Stay Protection Notice to All Relevant Officers did nothing to stop it. The 2nd Bench Warrant Arrest was a Protection Breach Contempt Fraud by the Magistrates Court, the Crown Prosecutors and Hertfordshire Police.
 - 4.3. The 418267126 Crime Complaint is a Complaint Fraud that is the subject of the Counter Complaint.
5. The Aggravating Circumstances include three other Framing Frauds against me by Hertfordshire Police:
 - 5.1. Uninsured Driving Framing Fraud 41CT1201622 by Hertfordshire Police got Trial Hearing Denial Frauds + Appeal Hearing Denial Frauds + Enforcement Failures by Law Courts raise Case Record Fraud Suspicions.
 - 5.2. Stop Failure Investigation + Driver Identification Investigation Frauds got Framing Fraud 41CT1345226 Plea Hearing. It got a Defence Papers Rejection Fraud + Legal Assistance Denial Fraud + Hearing Denial Fraud by the Magistrates Court against me. The Prosecutor said he wanted 10 minutes for the Case Officer. Equity Lawyer Mr Ellis said the Defence needed an hour. It got the Public Gallery Clearance Order and all the process that got the 418261826 + 418267026 + 418267126 Framing Frauds against Citizen Mr Nkrumah, me and the 2nd Bench Warrant Arrest Fraud against the Equity Lawyer.
 - 5.3. Traffic Light Direction 1.7 Second Breach Framing Fraud 0413050854905220 on 15th June 2026
6. The 2nd Witness Intimidation Counter Complaint is that Case 418267126 got Internet Publicity that is a Confidence Sabotage Fraud. It suggests there will be Repeat Mental Health Frauds against me. The 2nd Witness Intimidation Counter Complaint will discover what, if anything, Hertfordshire Police does about the Justice Perversion Fraud.
7. Budget Fraud Enquiries will discover how much All Relevant Authorities spend on the Framing Frauds.
8. The 1st Bench Warrant Arrest Fraud used Budget Frauds by Essex Police. Tax Collections by Chelmsford City Council help finance the Police Budget. The Budget Fraud Enquiry Test of the City Council is in progress.
