The World War III Peace Plan States lost control to Endemic Corruption Managers. Budget Frauds got Massive Debt. The Peace Plan got Corruption Remedy Test Case Status for the UK and Test Manager Status for the Coronation Oath Enforcement Authority, Interested Party Status for the Peace Plan States and the Common Law for the Just World Order. The Test Case needs Budget Fraud Enquiries for Indemnity Claims against Fraud Manager and Fraud Beneficiaries. The Peace Plan States need to know what impact Budget Fraud Enquiries have on Budget Fraud Management. The Budget Fraud Enquiries start with Criminal Cases but will cover everything. Asset Thefts + Asset Freezing Frauds got the Housing Benefit Qualification for Equity Lawyer Mr Ellis.

1. Asset Theft was Client Money Theft by Regulated Lawyers.
2. An Inheritance Tax Clearance Certificate Denial Fraud by HM Revenue & Customs that denied him the Probate Estate of his dead brother. Chelmsford Council can make an Indemnity Claim for all the Housing Benefit. It enabled Natwest Bank to steal £35,000 from a Bank Account. Everything in the estate was lost.
3. A Bank Account Closure Fraud + Content Theft by Barclays Bank. The Equity Lawyer developed Advanced Electronic Signature Technology. European Leaders made a Personal Profit Plan. It needed Copyright Theft, Forced Usage in the EU and Usage Licence Fees for them. Barclays Bank Group Board serviced the 1st Theft Plan. They used Low Rank Bankers who did not know how to do it. The Equity Lawyer realised what was happening and got the evidence. They failed. Barclays Bank Group Board serviced the 2nd Theft Plan. It needed a Bankruptcy Fraud. They used people the Equity Lawyer had known for decades. He got the evidence. It failed. The Kent Senior Manager helped get the Fraud Proof against the Group Board. They forced the Account Closure Fraud + Content Theft. The Equity Lawyer used Share Dividend Payment Instructions to that Bank Account for a Bank Fraud Investigation.

All Frauds got Housing Benefit Indemnity Rights for Chelmsford City Council.

The Peace Plan Leaders want to know:

1. what Chelmsford City Council do with the Budget Fraud Indemnity Rights.
2. what Chelmsford City Council do with Health Budget Fraud Proof that absorb resources that should be available for Chelmsford Constituents. Equity Lawyer Mr Ellis is NHS Patient 6328556020. Medical Records are Budget Fraud Proof. He has given a Confidentiality Waiver + Data Protection Waiver for the Health Budget Fraud Test.

Comparator Case Notice

In about 1980, a Housing Grant Fraud Complaint by the Equity Lawyer for a Client to a Shepway District Councillor got an Informal Investigation by Council Leaders. It discovered that:

1. Grant Application Denial Frauds by Council Officers enabled 90% of the Grant Budget went in Grant Payments to a Property Dealer or financed Grant Work he did for others
2. Council Leaders took No Remedy Action that inspired the Councillor to found a Charity Company, with Secured Creditor Control for him, to manage a Fraudulent Preference of an £80,000 Land Sale by the Council to the Charity with intent to manage Plunder Frauds against the Charity to get Residential Development Profits.

The Equity Lawyer managed Spoiler Operations against the Charity Plunder Frauds. The Councillor died in 1999. The Common Law validates use of the Fraud Proof for Recovery Action: If undeveloped then Debt Repayment Forfeiture + Forced Return of the Land Title. If developed, then Profit Tracing + Recovery.

The Peace Plan Leaders are interested to know:

1. What response a Fraud Notice gets from Shepway District Council 45 years later
2. Whether other Local Authorities have Similar Fact Cases and, if so, what happens to them
