Budget Fraud Enquiry Service Request

The Western Democracies lost control to Endemic Corruption. Budget Frauds got Crippling National Debts. UK Citizens made a Recovery Plan Queen Elizabeth and Prince Charles agreed it. They needed Criminal Conspiracy Proof against a serving Prime Minister and International Support. In 2004, preparations for the European Union Referenda got Election Fraud Conspiracy Proof against EU Leaders including Prime Minister Mr Blair. The Election Fraud Concealment Plan got Criminal Conspiracy Proof against them. Equity Lawyer Mr Ellis gave it to Queen Elizabeth. She used it for the Recovery Plan. Equity Lawyer Mr Ellis spent years getting Endemic Corruption Proof. Queen Elizabeth and Prince Charles spent years using it to get International Support.

In 2023, King Charles negotiated the World War III Peace Agreement for Democratic States. The December G7 Summit got Agreement Signatures. The Peace Agreement requires Sovereign States to destroy the Protection Fraud Networks that manage Endemic Corruption, recover control of State Budgets, resource World War III Defences and resource a Just World Order. The Management Agreement got Corruption Remedy Test Case Status for the UK, Test Manager Status for the Coronation Oath Enforcement Authority, Interested Party Status for the Peace Plan States and the Common Law for the Just World Order.

The Corruption Remedy Test Case needed:

1. A Split Judiciary with some wanting Safe Conditions to make Court Fraud Admissions.
2. Budget Fraud Enquiries of All Relevant Budget Managers about the cost of:
 - 2.1. A Complete Set of Old Framing Frauds
 - 2.2. New Framing Frauds with Budget Fraud Enquiries of Budget Managers as the case progresses

The Test Case got both. The Budget Fraud Enquiries can start at the beginning, end or in the middle. Councillors have Interested Party Status for two reasons:

1. Council Tax Revenues resourced Local Budgets that were used for Plunder Frauds or Protection Frauds.
2. National Budget Frauds stole the resources that should have serviced Local Constituents.

The Dictator Governance Plan for Western Europe vested Dictator Powers in the Cabinet. The Politicians lost control to Crime Partnerships of State Officers and Law Court Judges. They developed a Protection Fraud Network to provide Support Services and manage Co-ordinated Corruption. They merged Local Crime Businesses into a National Business. They started with Tobacco Duty Evasion Frauds and Drug Crimes. Protection Frauds that use State Resources are Budget Frauds against the Cabinet. The Protection Fraud Network existed to make money. It made Business Expansion Plans. They needed Case Management Research to discover what was needed to manage Court Frauds on an Industrial Scale. They needed Judiciary Control and then Cabinet Control with a Cabinet Profit Share Limit.

In the early 1980's, Medical Research linked Mine Conditions to Mine Diseases that got a Mass Claim by 400 Canadian Miners that were underwritten by two Lloyds Syndicates. The Names included 65 Judges and 35 MPs including the Attorney General. A £35,000 Release Fraud for them was an Increased Liability Transfer Fraud against the Other Names. It needed Fraud Enforcement. The Insolvency Act 1986 stripped Bankruptcy Fraud Victims of Accountability Rights. It was the Fraud Enforcement. It got Judiciary Control. They sold Protection Frauds for Industrial Scale Frauds.

In 1997, the General Election got a Landslide Governing Majority for Prime Minister Mr Blair and Cabinet Office for Mr Peter Mandelson. Mr Blair sold Policy Waiver Frauds and used Mr Mandelson as Marketing Manager. They used the £1,000,000 Fee for the Tobacco Advertising Waiver for Formula 1 Racing as a Marketing Tool. Mr Mandelson used Cabinet Office to manage the Business Expansion Plan of Performance Enhancing Drugs to Sports Professionals and Fitness Fanatics. He did not tell Mr Blair because he would have demanded too much. In 2004 the preparations for the European Referenda got Election Fraud Conspiracy Proof against the European Union Leaders, including Mr Blair. The Election Fraud Concealment Plan got Criminal Conspiracy Proof against them. The process exposed the Protection Fraud Network. It got a Profit Share for Mr Blair and Cabinet Control.

Equity Lawyer Mr Ellis gave it to Queen Elizabeth. She used it for the Recovery Plan. Corruption Management by Mr Mandelson and then Lord Mandelson did Budget Fraud Damage to All Relevant Authorities including Chelmsford City Council and Essex County Council. Career Ruin Frauds + Pension Thefts got State Benefit Dependency for Victims. Protection Frauds used Health Frauds that did Budget Fraud Damage to everyone who used Health Services. Bribery got Housing Benefit Excess Payment Frauds for Landlords. The Budget Fraud Enquiries will get Damages Recovery.
