Scandal Remedy Experiment:

All Party Support for Reform Party Leader Mr Farage in asking the Generous Donors to found a Registered Charity to service the Just World Order Objective + use the Generous Donation to resource Political Unity of All Local Councillors for Budget Fraud Enquiries and Indemnity Claims + reduce Budget Fraud Losses + use Indemnity Recovery to reduce National Debt + find the True Budget + make best use of it + Market Fraud Enquiries to identify Remedy Denial Frauds for Vested Interests against the People.

The People need Viable Political Parties to manage Viable Democracies. The Scandal is that Endemic Corruption has got a Confidence Collapse in the Integrity Standard of Political Parties. The challenge is Confidence Recovery. The UK Leadership Contest Denial Fraud + Premier Appointment Fraud for Mr Burnham did nothing for Confidence Recovery. Backdated Legislation to invalidate Financial Contributions to Political Parties will not get Confidence Recovery.

What will? Something might. It is Transparent Policy Research how to service the World War III Peace Plan for Democratic States and achieve a Just World Order.

Queen Elizabeth and Prince Charles spent decades preparing to get the World War III Peace Plan for Democratic States. She died knowing he would get it.

In 2022, Leadership Contest Frauds used Support Vote Offers by the Network on Protection Fraud Conditions. Offer Refusals by Mr Sunak and Mr Hunt Remedy enabled Offer Acceptance by the Hopelessly Incompetent Ms Truss. Within 7 weeks, Crisis Conditions created the need for Mr Hunt to take office as Chancellor of the Exchequer and Mr Sunak as Prime Minister. They did not have the power for a Cabinet Office Purging Operation against Network Agents. When Mr Cameron was Prime Minister, he did everything asked of him by the Crown and Parliament Sessions Court to service Top Level Corruption Investigations. In 2023, he served as Peace Plan Negotiation Agent for King Charles. An Honourable Peerage got the Office Qualification for Foreign Secretary. He and Mr Sunak attended the G7 December Summit and got the Agreement Signatures.

The Peace Agreement requires Sovereign States to destroy the Protection Fraud Networks that manage Endemic Corruption, recover control of the State Budgets, resource World War III Defences and resource a Just World Order. The Management Agreement got Corruption Remedy Test Case Status for the UK, Test Manager Status for the Coronation Oath Enforcement Authority, Interested Party Status for Peace Plan States and the Common Law for a Just World Order. The Remedy Agreement got Remedy Enforcement against Fraud Profiteers and Penal Enforcement against Political Leaders. The Delivery Agreement got Delivery Commitments, some of which are conditional. The Publicity Agreement got Whole Plan Secrecy and Mass Publicity for Plan Stage Successes until there is enough for Whole Plan Publicity.

Remedy Co-operation by the Peace Plan Signatories financed the Remedy Budgets for the Post Office Scandal and Contaminated Blood Scandal. They got the Remedy Budget Plunder Fraud Scandal without clear explanations that is what it is. Corruption Exposure got an increase in the MP Retirement Rate, an Incredible Choice in the 2024 General Election, a Split Conservative Values Majority Vote that enabled a Minority Vote to get a Landslide Governing Majority led by Sir Keir Starmer. It got a Power Transfer from Network Agents using the Conservative Party to Network Agents using the Labour Party.

The 2024 Parliament Sessions Grant required Remedy Delivery: 20,000 Imprisonment Fraud Releases, Dismissal Executions against the Judiciary by a United Parliament, Victim Identification and Case Remedies. They forced the UK Cabinet made a Priority Choice for Budget Fraud Profits against Remedy Delivery. The 3,500 Guilty Prisoner Releases for the Overcrowding Reason was a Grant Condition Breach. It got a Remedy Delivery Fraud Finding against the Cabinet and the Default Dismissal Penalty against Prime Minister Mr Starmer.

Co-operation by the Peace Plan Signatories supported Reform Party Leader, Mr Farage, and Conservative Party Leader, Ms Badenoch, in use of the Child Prostitution Scandal to extort Remedy Delivery Commitments from the UK Cabinet. They were Commitment Frauds. They got the Treason Deal Scandal + Epstein Scandal + Mandelson Scandal + Leadership Denial Fraud Scandal + Iran War Scandal + UK Premiership Appointment Fraud for Mr Burnham Scandal.

The Corruption Remedy Test Case has reached the Budget Fraud Enquiry Stage. It needs Budget Fraud Enquiries of Managers and Victims and manage Indemnity Claims against Fraud Managers and Fraud Beneficiaries.
