Technology Theft Conspiracy. The EU Leaders made a Personal Profit Plan. Prime Minister Mr Blair was the Plan Manager. It needed Source Code Theft + Forced Usage in the EU + Licence Fees for the EU Leaders + Competition Sabotage Frauds using Business Ruin Frauds against the Post Office.

The 1st Theft Effort. The UK Secret Service made Licence Fees for the UK State a Theft Condition. It defeated the Personal Profit Plan. Prime Minister Mr Blair used Barclays Bank Group Board. They used Low Rank Bank Officers who did not know how to do it. They gave themselves away at every stage of the process. The Business Ruin Frauds against the Post Office was the Forced Transfer of Loss-Making Accounts to the Banks. The Group Board instructed the Low Rank Officers to make a series of Technology Assessment Appointments and then Appointment Delays until they knew the outcome of the Forced Transfer of the Loss-Making Accounts. TV News covered the Forced Transfer Meetings of the Cabinet and the Banks. Resistance by the Banks delayed the process from April to September 1998. The Equity Lawyer noticed the coincidence of the Forced Transfer Meetings and the Assessment Appointment Delays. He managed the process to get Source Code Theft Proof against the Bank Officers. In 1999, he entered the Writing Analysis Technology in the Geneva Inventions Exhibitions. It got a Gold Medal that was Originality Proof. In 1999 and 2000, the Kent Senior Manger assisted a Source Code Theft Investigation that discovered Barclays Bank was managing the Source Code Theft. It discovered Barclays Bank Group Board were the Theft Agent. They had Protection frauds from the Bank of England, Cabinet and Prime Minister Mr Blair.

Market Exclusions The EU Leaders used the Advanced Electronic Signatures Statutory Instrument 2002 for EU Market Access Frauds against the Equity Lawyer. The Equity Lawyer kept the Theft Conspiracy Proof + Originality Proof for USA Jurors. It denied the Theft Conspirators access to the USA Market for Execution Code Products.

The 2nd Theft Effort. The Personal Profit Plan used Attempted Bankruptcy Frauds with intent to get Source Code Theft from the Bankrupt Estate. It failed. Prime Minister Mr Blair used State Authorities to get Insolvency Conditions but needed Fraud Completion by Private Agents the Equity Lawyer had known for decades. Every stage of the process got Bankruptcy Fraud Conspiracy Proof against All Liable Parties. It included RH Ellis Estate Probate Denial Frauds by the Widow and Regulated Lawyers and Law Courts + Law Practice Disqualification Frauds by the Law Society and Law Courts + Client Money Theft and Partnership Dissolution Payment Denial Frauds by Regulated Lawyers and Law Courts + Taxation Frauds by HM Inland Revenue and the Law Court

The Bankruptcy Fraud Failure got a Confidence Collapse by Barclays Bank Group Board. They retired the Senior Manager who got the Theft Conspiracy Proof against them. They used a Premier Account 30357510 sort code 20 02 62 Closure Fraud and Contents Theft for a Relation Termination with the Equity Lawyer. He anticipated events. He serviced the Bank Fraud Investigation, whenever it happened, by directing Quoted Company Share Dividend Payments into the Bank Account. It got Dividend Theft Proof against either the Bank or Quoted Companies.

Lord Mandelson managed Business Expansion Plans for the Protection Fraud Network. One was Land Frauds for Big Owners against Small Businesses. Farmer Mr Charles Sydney Ellis was one of the Business Priming Case Victims. In 2009, the Expense Account Scandal motivated Protection Fraud Demands by the Judiciary that got a Murder Order from Prime Minister Mr Brown using a Cancer Treatment Denial Fraud. On 12th June 2029, the Secret Service serviced the Murder Order. On 12th October 2009, Personal Service of a Governance Fraud Claim on the Prime Minister and Secret Service motivated the Secret Service to give the Murder Proof Set to the Crown. He died on 1st February 2013. An Inheritance Tax Clearance Certificate Denial Fraud + Passport Identity Proof Denial Fraud are a Probate Grant Denial Fraud + Asset Freezing Fraud. It enabled a £35,000 Theft by Natwest Bank from Current Account 76972240 sort code 60 16 04. They do not deny it.

In 2004, the Corruption Remedy Process of the Coronation Oath Enforcement Authority and in 2023, the Peace Plan Test Case got Investigation Asset Status for the Scottish Widows Pension. The Pension Managers stole hundreds of thousands. The Peace Plan Leaders need it to set Recovery Precedents.
