REASONS

1. The UK Judiciary is split. Some want Safe Conditions to give evidence that Duress Conditions forced Bribe Acceptance for Court Frauds. In 2023, King Charles negotiated the World War III Peace Plan for Democratic States is getting Safe Conditions. The process needs explaining.
2. In 2004, Equity Lawyer Mr Ellis got Criminal Conspiracy Proof against Prime Minister Mr Blair. He gave it to Queen Elizabeth. She used it to revive active service of the Coronation Oath Enforcement Authority and start a Corruption Remedy Process. It used Research Investigations to discover the structure and strength of Endemic Corruption Managers and then Remedy Delivery. The Standard Procedure is Dismissal Executions against the Judiciary by a United Parliament, Victim Identification and an International Agreement for a Just World Order. A Parliament Unity Failure gets a Special Procedure. The Coronation Oath Enforcement gets Endemic Corruption proof against the Judiciary. The Crown uses it to get an International Agreement for a Just World Order. International Support gets Remedy Enforcement against Fraud Profiteers to finance Remedy Budgets for Scandal Exposure. It increases the MP Retirement Rate that enables a Power Transfer to one or more New Governing Majority until Remedy Delivery.
3. In 2021, Protection Frauds by the Cabinet, Prime Minister Mr Johnson and Opposition Leader Sir Keir Starmer. It created the need for the Special Procedure.
4. In 2022, Gas Charge Frauds by British Gas motivated Remedy Claim JOOCM673 by Equity Lawyer Mr Ellis that got Claim Process Denial fraud Proof against the County Court. It was part of the Endemic Corruption Proof.
5. In 2022 and 2023, Bribery Management by Lord Peter Mandelson for the General Osteopathic Council and Pharmaceutical Industry got Osteopath Misdescription 2022 00069636 Trial Frauds and 2022 0062 Appeal Frauds against Citizen Ms Davies by the General Osteopathic Council and Worcester Judges. The Crown Court Appeal Judges needed to avoid a Trial Report by the Equity Lawyer to the Crown and Parliament Sessions Court. They used Court Officers for an Assault Complaint Fraud that got the West Mercia Police Investigation 22CA1074323 + Arrest Fraud + Custody Fraud + Innocence Evidence Concealment Frauds + Charge Fraud + Bail Fraud. Crown Court 1 was the Crime Scene. The Audio Records were Event Records. It was part of the Endemic Corruption Proof against the Judiciary.
6. In 2022 and 2023, Contempt Claims by the Equity Lawyer and Cabinet got Imprisonment Fraud against the Equity Lawyer. It completed the Endemic Corruption Proof Set against the High Court and Court of Appeal.
7. King Charles used the Endemic Corruption Proof to negotiate the World War III Peace Agreement for Democratic States. The G7 December Summit got the Agreement Signatures. Remedy Enforcement against Fraud Profiteers financed Remedy Budgets for the Post Office Scandal and Contaminated Blood Scandal. Corruption Exposure enabled the 2024 General Election to get a Power Transfer from Protection Fraud Network Agents using the Conservative Party to Network Agents using the Labour Party. The 2024 Parliament Session Grant started the Power Transfer Process against them. It used the Child Prostitution Scandal + Treason Deal Scandal + Epstein Scandal + Mandelson Scandal + Starmer Scandal + Leadership Contest Denial Fraud Scandal that got the UK Premiership Appointment Fraud for Mr Burnham Scandal. Budget Fraud Test Cases forced him to choose a Just World Order or Budget Fraud Profits.
8. Corruption Exposure of Lord Mandelson motivated the Ruin Frauds against Citizen Mr Nkrumah. In 2026, they were Faming Frauds 2022 0043 +2023 1180 + Harassment Claim Fraud CM25F905967 + Restraint Fraud Breach Framing Frauds 01KG1226225 + 01KG1230725 + Other Cases. Mr Burnham made Nkrumah Case Closure Frauds an Appointment Fraud Condition. It enables Budget Fraud Enquiries of Essex Authorities + Others
9. The Bench Warrant Forgery 22CA1074323 Arrest Fraud Appeal by the Equity Lawyer got Jurisdiction Acceptance + Case Paper Receipt Stamps from Chelmsford Crown Court.
10. The Essex Budget Frauds did Consequential Damage to Chelmsford City Council. The Budget Fraud Enquiries will enable Indemnity Case Management by Chelmsford City Council. It gets Safe Conditions for the Judges to give evidence that Duress Conditions forced Bribe Acceptance for Court Frauds.
