Complaint: Common Law Justice Perversion Contempt by a Filing Refusal of the Scheduled Documents:

Circumstances

1. In 2023, King Charles used Endemic Corruption Proof against the Judiciary to negotiate the World War III Peace Agreement for Democratic States. The G& December Summit got Agreement Signatures. The Peace Agreement requires Sovereign States to destroy the Protection Fraud Networks that manage Endemic Corruption, recover control of State Budgets., resource World War III Defences and resource a Just World Order. The Management Agreement got Corruption Remedy Test Case Status for the UK, Test Manager Status for the Coronation Oath Enforcement Authority, Interested Party Status for the Peace Plan States and the Common Law for the Just World Order.
2. International Support got the Post Office Scandal + Contaminated Blood Scandal + Remedy Budget Plunder Fraud Scandal. Corruption Exposure got an increase in the MP Retirement Rate and an Incredible Choice for the 2024 General Election, and a Split Conservative Values Majority Vote that enabled a Minority Vote to get a Landslide Governing Majority. It was a Power Transfer from Protection Fraud Network Agents who used the Conservative Party to Network Agents who used the Labour Party. The 2024 Parliament Session Grant service the Power Transfer against them. It used the Child Prostitution Scandal + Epstein Scandal + Mandelson Scandal + Starmer Scandal + Leadership Cost Denial Fraud Scandal + UK Premiership Appointment Fraud for Mt Burnham Scandal.
3. The Peace Plan needed Budget Fraud Cases that force Prime Minister Mr Burnham to choose between the Just World Order and Budget Fraud Profits. The State Frauds + Court Frauds against the Citizen are Budget Frauds that get Indemnity Rights for All Relevant Authorities against the Fraud Managers + Fraud Beneficiaries.
4. In 2023, Bribery Management by Lord Mandelson for the General Osteopathic Council and Pharmaceutical Industry got Osteopath Misdescription 2022 00069636 Trial Frauds and 2022 0062 Appeal Frauds against Citizen Ms Davies by the General Osteopathic Council and Worcester Judges against Citizen Ms Davies. The Crown Court Appeal Judges needed to avoid a Trial Report by the Equity Lawyer to the Crown and Parliament Sessions Court. They used Court Officers for an Assault Complaint Fraud that got the West Mercia Police Investigation 22CA1074323 + Arrest Fraud + Custody Fraud + Innocence Evidence Concealment Frauds + Charge Fraud + Bail Fraud. Crown Court 1 was the Crime Scene. The Audio Records were Event Records. It was part of the Endemic Corruption Proof that King Charles used to negotiate the World War III Peace Agreement for Democratic States.
5. In 2026, the UK Premiership Appointment Fraud got a Split Judiciary. Some want Safe Conditions to give evidence that Duress Conditions forced Bribe Acceptance for Court Frauds.
6. In March 2026, Case 22CA1074323 Frauds by the State and Magistrates Court got the Fraud Appeal by the Equity Lawyer and Jurisdiction Acceptance by Chelmsford Crown Court. It got Receipt Stamp Proof on the Case Papers that were Set Up Conditions for the Budget Fraud Enquiries
7. In August 2026, Case 22CA1074323 Frauds by the State and Magistrates Court got a Case Transfer from Worcester via Hatfield to Chelmsford Magistrates Court. It enabled completion of the Set Up Conditions for the Essex Budget Fraud Enquiries. Some of the Essex Judges received Bribe Money Laundering Services from Network Drug Wholesaler Mr Benjamin Koomson. They cannot credibly claim Duress Conditions. On 16th September 2026, the Budget Enquiry Papers for Chelmsford City Councillors got Crown Court Receipt Stamps. ON 18th September 2026 the Budget Fraud Case Papers got Filing Refusal. The Peace Plan States need to know why.
