5. Conflicted Interest Finding for Honourable Officers of Interested Parties who service Equity Governance Obligations against Perverse Officers of Interested Parties who are Original Crime Managers or Original Crime Beneficiaries or Protection Fraud Managers. Reason: Effective Accountability
6. Conflicted Interest Voluntary Disclosure Obligation Finding + Conflicted Interest Sub-Group Identification Order for the Citizen against the Interested Party Honourable Officers and Interested Party Perverse Officers. Reason: Effective Accountability
7. Credibly Independent Separate Representation Order for the Citizen against the Interested Parties and Sub – Group Interested Parties. Reasons: Effective Accountability + Proportionality Controls
8. Conflicted Interest Finding for the Budget Fraud Victim Status of the Local Authority Cabinets and the UK Cabinet against the Cabinet Perverse Officers for Self-Evident Reasons.
9. Conflicted Issue Discovery Disclosure Order for the Citizen against the Interested Parties that within 7 days they file and service Response Statements to the question whether they wish to admit, deny or require proof of the Constitution Schedule Content + Case Schedule Content.
10. Contempt Investigation Directions Hearing at on October 2026
