Protection Rights

The UK Corruption Remedy Process and the World War III Peace Plan Test Cases got Pending Remedies Enforcement Stay Protection Rights for Equity Lawyer Mr Edward Ellis + Citizen Mr Nkrumah + Other Citizens from the UK Parliament Sessions Court

The 22BA1074323 Forged Bench Warrant got an Arrest Fraud + Validity Investigation Denial Frauds + Remand Fraud on 15th March 2026 by Hertfordshire Police and Essex Police + Arrest Validity Investigation Denial Fraud on 16th March 2026 by Chelmsford Magistrates Court + Fraud Appeal on 20th March 2026 that got Pending Remedies Enforcement Stay Protection for Equity Lawyer Mr Ellis + Citizen Witness Mr Nkrumah + Other Citizen Witnesses from Chelmsford Crown Court against the Inferior Jurisdictions of the State and Magistrates

Protection Breach

At 10.07 on 25th September 2026 a Telephone Call for 4 minutes 23 seconds from an Anonymous Officer to Equity Lawyer Mr Ellis was a Custody Notice that Citizen Mr Nkrumah was in Harlow Police Station. It got a Witness Protection Rights Notice from the Equity Lawyer Mr Ellis and Don't Want To Know Responses + Call 101 Advice from the Anonymous Officer. The Identification Request got an Identification Refusal. The Record Entry Request got a Record Entry Agreement and then a Call Termination that prevented provision of the Protection Rights Details.

In 2023, the Coronation Oath Enforcement Authority got Endemic Corruption Proof. King Charles used it to negotiate the World War III Peace Agreement for Democratic States. The Peace Agreement requires Sovereign States to destroy the Protection Fraud Networks that manage Endemic Corruption, recover control of State Budgets, resource World War III Defences and resource a Just World Order. The Management Agreement got Corruption Remedy Test Case Status for the UK, Test Manager Status for the UK Coronation oath Enforcement Authority, Interested Party Status for the Peace Plan States and the Common Law for the Just World Order. The Remedy Agreement got Remedy Enforcement against Fraud Profiteers and Penal Enforcement against Political Leaders. The Delivery Agreement got Delivery Commitments some of which are conditional. The Publicity Agreement got Whole Plan Secrecy and Mass Publicity for Plan Stage Successes without disclosure that is what they are, until there are enough for Whole Plan Publicity.

Remedy Enforcement by Japan and the USA against Fraud Profiteers financed the Remedy Budgets for the Post Office Scandal and the Contaminated Blood Scandal. It got Remedy Budget Plunder Fraud Proof against the Regulated Professions. Scandal Exposure got an increase in the MP Retirement Rate, an Incredible Choice in the 2024 General Election, and a Split Conservative Values Majority Vote that enabled a Minority Vote to get a Landslide Governing Majority. Led by Sir Keir Starmer. It was a Power Transfer from the Network Agents that used the Conservative Party to Network Agents that used the Labour Party. The 2024 Parliament Sessions Grant serviced the Power Transfer Process against them. The Corruption Remedy Conditions required: 20,000 Imprisonment Fraud Releases + Dismissal Executions against the Judiciary by Parliament + Victim Identification + Case Remedies. Cabinet Officers who were Network Agents had procured many thousand Imprisonment Frauds. Prime Minister Sir Keir Starmer did so as Director of Public Prosecutions. They dare not acknowledge any Imprisonment Frauds. 3,500 Guilty Prisoner Releases was a Session Grant Breach that got a Fraud Finding against the Cabinet and Dismissal Decision against Prime Minister Sir Keir Starmer. The Peace Plan provided International Support. They extorted the 3.5% Defence Budget Commitment. It needed Total Termination of Budget Frauds. They Remedy Delivery and chose the Ruin Frauds managed by Essex Police + Others against Citizen Mr Nkrumah to start Victim Identification + Case Remedies. The Epstein Scandal + Mandelson Scandal + Starmer Scandal + Leadership Contest Denial Fraud Scandal + UK Premiership Appointment Fraud for Mr Burnham Scandal got Set Up Conditions for the Budget Fraud Tests. On 28th August 2026 there were Protection Breach Frauds by Hertfordshire Police against Citizen Mr Nkrumah. On 16th September 2026, Chelmsford Crown Court provided Receipt Stamp Proof on the Budget Fraud Enquiry Advice for Essex Councillors. It got a Panic Reaction from Crown Court Judges. 18th September 2026 got a Court Filing Refusal. Councillors and Journalists had agreed to service the Budget Fraud Tests. 26th September 2026 got the Essex Protection Breach.
