The Schedule - Fraud Allegations

A Corruption Investigation is needed to discover whether Fraud Profits is the Governing Motive for the Forgery + Perjury + Justice Process Contempt Crimes committed by the 2 Car Collision + Rear Shunt Damage Claim. The 1 Car Collision with a Near Side Motorway Barrier did Front Near Side Wing Damage. A Mobile Image is No Car Front Damage Proof. The Case Management by the Claim Lawyers and the Unidentified Law Court adds to the Fraud Proof: Long Delay of 1 year 11 months and 10 days from Alleged Event to the Claim Telephone Call and then the Claim Email at 10.59 on 26th November 2024 from Claim Lawyer Gilau Renette of DLG Legal Services to the Citizen Mr Woods + Claim Evidence of a Video but No Repair Cost or No Insurance Excess Loss or the Insurance Payment that the Insurance Excess Loss implies + No Disclosed Insurance Involvement + Long Delay of 11 months and 14 days from Claim Notice to the Claim Particulars dated 9th November 2025 + Long Delay of 23 days from production of the Claim Particulars to On Line Claim Filing on 2nd December 2025 + Claim 762MC054 Service Notice dated 3rd December 2025 from No Identifiable Law Court but a State Agency called the HM Courts and Tribunal Centre + Service Enclosure of the On Line Claim Form that bears what appears to be a Printed Stamp of an Unidentified County Court and the Claim Particulars + No Email Service + Long Delay of 226 days from Claim Service to Default Judgment dated 16th July 2026 that gives the County Court at Online Money Claims as the Court Identity + Default Judgment Postal Service

The Collision Event. The Budget Insurance Policy 135348550 01 001 02 dated 7th November 2022 of Mrs Marylin Hawes of car registration KU61ZWS covered her husband, Citizen Mr Woods. On or about 16th December 2022, he drove and she was the passenger. They were on the M1 north bound carriageway about 3 miles south of Luton Airport Junction when he lost attention, collided with the barrier and did Small Damage to the Front Near Side. The Only Known Event Witness was an Unidentified Man who was driving behind them. He stopped, presented as having Police Practice Experience, took control of events, said he was travelling to Newcastle, stayed about half an hour and left. Citizen Mr Woods or Mrs Hawes made a Mobile Phone Help Call to her son Mr Peter Hawes, who is an Insurance Actuary. He attended the scene, took a Mobile Phone Image of the Car Front + Barrier that reveals No Front Damage, and made a Mobile Phone Incident Report Call to Herefordshire Police. It got a Trivial Incident Finding + Police Boundary Location Finding + Attendance Refusal from Hertfordshire Police. The Repair Cost would have exceeded the Old Car Value. An Insurance Claim would have got disproportionate Premium Increase. They scrapped it. A Service Call to AA got Car Removal + Disposal by Private Contractors.

Defence Delay.

1. Citizen Mr Woods was born on . He had Professional Standard Competence + Career Successes that made him a Ruin Fraud Target for the Protection Fraud Networks of the UK and California.
2. On the evidence available, in 2021, the Covid Vaccine caused Senile Decay. It motivated a Priority Decision for Health Services against a Vaccine Damage Claim. Health Treatment got Health Improvements and Substantially Improved Management Capacity, but Lifetime Professional Standards Awareness + Temporary Incapacity got a Confidence Loss. He had Issue Understanding but Minor Chores like Dog Walking + Meal Preparation had effect as a Focus Distraction. It deprived him of the Management Capacity for Substantial Business. He had Claim Knowledge but Fraud Defence Incapacity.
3. Case Activity motivated Help Requests by Citizen Mr Woods to Equity Lawyer Mr Ellis: Whatsap Calls - Missed Calls on 2, 16 and 17 December 2024 + 1 and 22 January 2025 + 3 and 27 February 2025 + a Voice Call of 11 Minutes on 6 March 2025. that got Information Requests from Equity Lawyer Mr Ellis that got Incomplete Disclosures. Mobile Calls between Citizen Mr Woods 078484 541726 and Equity Lawyer Mr Ellis 07788371717 in

2026 – 09.41 for 17 minutes 36 seconds on 26 August + 15.15 for 6 seconds on 28 June + 11.40 for 2 seconds and 13.25 for 3 minutes 57 seconds on 29 June + 15.37 for 23 minutes 6 seconds on 24 July + 10.59 for 4 minutes 58 seconds on 29 July + 10.11 for 1 minute 57 seconds and 11.18 for 2 minutes 16 seconds on 3 August + 09.34 for 21 minutes 9 seconds and 17.04 for 1 minute 19 seconds on 17th August + Missed Calls at 16.35 and 17.44 and 17.46 on 21 August + Whatsapp Call at 17.47 for 4 minutes 0 seconds + Missed Reply + on 21 August 2026 Oral Notice of Claim Case Papers and Production Failures motivated a Defence Evidence Quality Control.

4. The Contempt Remedy DRAFT Application dated 17th August 2026 produced by the Equity Lawyer was intended to get, but did not get, Corrections + Additions from Citizen Mr Woods. The Claim Management Delays exploited the Focus Distraction

The Schedule - Contempt Investigation Proposals

The Corruption Investigation needs to discover:

1. Who knew about the 1 Car Collision and kept Collision Evidence for a Claim Fraud and No Other Possible Purpose
2. Why Regulated Lawyers took the Crime Penalty Risk of Forgery + Perjury + Contempt to get a £4951.54 Judgment Fraud against an Impoverished Old Man who has State Benefit Dependency.
3. Why the Alleged Law Court failed to notice and remedy the Self-Evident Fraud of a £100 Insurance Excess Loss by an Insured, that implies an Insurance Claim and No Explanation of the Uninsured Loss
4. What was the Service Receipt Proof used by the Claim Lawyers and Alleged Law Court for the Default Judgment
5. What got replacement by Regulated Professions, the State and Law Courts of the Integrity Management Systems with the Fraud Management Systems that serviced the Case 762MC054 Frauds
6. What are the connections between the Case 762MC054 Frauds and: The Ruin Fraud Conspiracies by the Protection Fraud Networks of UK + California against Citizen Mr Woods and the UK Protection Fraud Network against his wife, Mrs Marolyn Hawes + The World War III Peace Plan for Democratic States that got Corruption Remedy Test Case Status for the UK, Test Manager Status for the Coronation Oath Enforcement Authority, Interested Party Status for the Peace Plan States, the Common Law for the Just World Order and Ruin Fraud Test Case Status for Mr Woods and Mrs Hawes.

Circumstances

In the early 1990's, a Technology Development Sale got \$5,000,000 that Mr Woods used it to found a Family Trust using Californian Regulated Lawyer. It was Pension Provision for him and Inheritance Provision for his children. He lived off Earned Income. He lacked the Trust Expertise for Integrity Controls. It enabled All Assets Theft by the Corrupt Lawyers. Almost 30 years later, Retirement Trust Asset Call by Mr Woods. It discovered the Asset Theft and motivated Ruin Frauds by the UK Protection Fraud Network for the Californian Protection Fraud Network.

The Protection Fraud Network used Framing Frauds and Entrapment Frauds to get Sex Crime Blackmail Victims and Office Appointment Frauds to get Puppet Officers and a Reliable Supply of Fraud Services at No Profit Share Cost. Protection Frauds for Celebrity Sex Offenders provided Protection Fraud Reassurance for the Puppet Officers. In 2023, Publicity Management by Mrs Hawes forced a Sentence Appeal that got Cell Imprisonment of School Headmaster Sex Criminal Mr Carney. It got Ruin Fraud Target Status for her from the UK Protection Fraud Network.

In 2004, the preparations for the European Referenda got Election Fraud Conspiracy Proof against EU Leaders including Prime Minister Mr Blair. The Lawful Business of UK Citizens made inevitable exposure of the Election Frauds. The Election Fraud Concealment Plan used Netherlands Jury Trial Frauds for Imprisonment Frauds against two Lawful Business Managers. They needed Extradition Frauds against one who was a UK Citizen. The 1st Effort used Armed Dutch Police on UK soil to supervise UK Customs and Kent Police in a Kidnap Extradition Fraud. Everything that could go wrong for the EU Leaders did go wrong. It exposed the use of Cabinet Office and the Judiciary to provide Protection Frauds for Crime Business managed by State Officers and Law Court Judges, and the Lead Business was Drug Supplies by Top Police, Top Customs and Top Judges. The 2nd Effort got Immunity Frauds for the Top Drug Dealers, Election Fraud Concealment Services for the EU Leaders, An Extradition Treaty for the UK and Netherlands, an Extradition Warrant Fraud against the UK Citizen, a Network Business Profit Share for Prime Minister Mr Blair, Cabinet Control for the Protection Fraud Network and use of it for Business Expansion Plans managed by Twice Disgraced Politician Mr Peter Mandelson and a Criminal Conspiracy Proof against a serving Prime Minister. The Equity Lawyer and Queen Elizabeth used it to revive active servicer of the Parliament Sessions Court and start the Corruption Remedy Process.

In 2021, Mr Woods and Mrs Hawes met Equity Lawyer Mr Ellis. He realised they were Ruin Fraud Victims, asked for Case Evidence, got a Ruin Fraud Big Bundle from Citizen Mr Woods and asked for the Document Separation needed to make it Manageable Evidence for the Corruption Remedy Process. The 2021 Covid Vaccine did Incapacity Damage that denied the Document Separation. It denied use of the Ruin Fraud Conspiracy Proof to get the 2023 World War III Peace Plan Agreements. The Proof Set was far too important to ignore for Remedy Delivery: Dismissal Executions against the Judiciary by a United Parliament + Victim Identification + Case Remedies. In 2026, the Case 762MC054 Frauds caused the Equity Lawyer to discover the Case Management Incapacity + Partial Recovery. The Case 762MC054 Frauds can service the Budget Fraud Remedy Tests of All Authorities that have Budget Responsibilities. Old Cases can be kept for UK + USA Precedents for Victim Identification + Case Remedies.
