 - 8.2. The Expansion Plan needed Business Priming Cases to identify and reward Corrupt Professionals and identify and penalise Honest Professionals?

 - 8.4. The Fraud Motive was the Mistaken Belief that the Father knew the Grandfather managed Framing Frauds +

- 8.6. The Business Priming Case in England used the Criminal Father + Paternal Grandparents against the Mother, Mrs Theodorou + 6 Children?
- 8.7. The Victim Network introduced Mr Coyle to Mrs Theodorou and they became friends?
- 8.8. In June 2016, they met Equity Lawyer Mr Ellis and have provided Support Services for the Corruption Remedy Process and Peace Plan Remedy Test Case ever since?
- 8.9. In 2022, Hertfordshire Police had managed the Uninsured Driving Framing Frauds against Citizen Mr Coyle?
- 8.10. In 2026, the Stop Failure Investigation 41CT1345226 got Alibi Proof failed to get Valid Enquires but got Driver Identification Failure Pretence Frauds that validated the Framing Fraud Investigation that discovered use of Perjury + Forgery for 22CA1074323 Bench Warrant Fraud Arrest that got the Fraud Appeal + Pending Remedies Enforcement Stay Protection for Equity Lawyer Mr Ellis + Citizen Witnesses Mr Coyle and Mr Nkrumah from the Superior Jurisdiction of the Crown Court against the Inferior Jurisdictions of the State?

- 8.12. All of it added to the Fraud Proof Set for the Proof Burden Reversal?
9. All Cases against Citizen Mr Nkrumah have Corruption Remedy test Case Status because Bribery + Blackmail by Lord Mandelson managed Network Expansion Plans two of which used Ruin Frauds against Citizen Mr Nkrumah?
 - 9.1. The Expansion Plan for Performance Enhancing Drug Sales to Sports Professionals and Fitness Fanatics used Ruin Frauds against Honest Competitors who have Influencer Status?
 - 9.1.1. Citizen Mr Nkrumah had Influencer Status because Mo Farrar and he could beat each other at different distances, Mo became a Professional Sportsman, Akwasi became a BT Apprentice, was used by them as the Apprenticeship Marketing Model?
 - 9.1.2. The Conservative Party recognised his Influencer Status and used him to get the Young Black Votes for Mr Johnson in the London Mayoral Elections of 2004 and 2008, and for Mr Cameron in 2010?
 - 9.1.3. The 1st Ruin Fraud Conspiracy against him was a Copyright Piracy Framing Fraud + 1st Offence Imprisonment Fraud that did Career Ruin Damage?
 - 9.2. The Land Theft Expansion Plan for Network Agents against the State used Title Transfers + Housing Charity Letting Rights Transfers from Local Authorities Housing Associations, Destruction of Title Proof, Fabrication of Title Record Frauds and Industrial Scale Theft from the State Budget using Housing Charity Asset Sales from Network Agents to Housing Associations?
 - 9.2.1. Many thousand Tenancy Forgeries got Forgey Complaints by Citizen Mr Nkrumah motivated the 2nd Ruin Fraud Conspiracy against him, Good Management by him, Bad Management by Incompetent Officers created the need for Evidence Thefts, use of Drug Wholesaler Mr Benjamin Koomson for Electronic Device Thefts, and use by of the Chronically Immature Mother of the 3 Nkrumah Children for Theft Support Services created the need for Relationship Maintenance with her using prostitution of her, and use of her for prostitution of the 14 year old daughter, all of which enable Immunity Deals that get the Bribe Money Laundering Evidence from Mr Koomson against Local Police + Local Judges?
 - 9.2.2. On 16th September 2026, the 10th Paper Filing Event at Chelmsford Crown Court on the Budget Fraud Enquiry Documents prepared for Councillors and Journalists?
 - 9.2.3. A Confidence Collapse by Crown Court Judges evidenced by a Paper Filing Refusal Order?
 - 9.2.4. A Confidence Collapse by Top Police used the Chronically Immature Mother for Complaint Frauds + 42MR3193026 Investigation Frauds + 42DZ335220 Custody Frauds + 4213899920 Interview Frauds?
10. The 42MR3193026 Case Records evidence Arrest Frauds interrupted the Bicycle Journey of Mr Nkrumah and his two sons to school, Arrest Reason Failures got Reason Replacement Frauds evidenced by the Body Cam Records + Remote Control Audio Records + Inconsistencies between Live Records and Computer Entries. They evidence a Phased Desertion over 14 hours by Corrupt Officers using Record Frauds for Involvement Denial Frauds + Notice Denial Frauds + Control Denial Frauds. The Seized Bicycle became Found Property.

Best Advice for Budget Fraud Investigators – Compare the Computer Entries with Live Records. Fraud Notices got No Computer Entries + Escort Officer Identification Denial Fraud for a Body Cam Exclusion Fraud + Status Reversals by Interviewers + shouting down Citizen + Bail Condition Refusal by Citizen got Charge Refusal + Late Night Release.
