Budget Fraud Investigation Motion for Councillors v Officers

28th September 2026

Motion: A Budget Fraud Investigation to discover damage done to the capacity of Councillors to service Constituents.

REASON: Fraud Complaints by Constituents that:

1. In 2023, King Charles used the Endemic Corruption Proof to negotiate the World War III Peace Plan for Democratic States, and the G7 December Summit got Signature Agreements?
 - 1.1. The Peace Agreement requires Sovereign States to destroy the Protection Fraud Networks that manage Endemic Corruption, recover control of State Budgets, resource World War III Defences and resource a Just World Order?
 - 1.2. The Management Agreement got Corruption Remedy test Case Status for the UK, Test Manager Status for the Coronation Oath Enforcement Authority, Interested Party Status for the Peace Plan States and the Common Law for the Just World Order?
 - 1.3. The Remedy Agreement got Remedy Enforcement against Fraud Profiteers and Penal Enforcement against Corrupt Leaders?
 - 1.4. The Delivery Agreement got Delivery Commitments some of which were conditional?
 - 1.5. The Publicity Agreement required Whole Plan Secrecy and Mass Publicity for Plan Stage Successes without disclosure that is what they are until there is enough for Whole Plan Publicity?
2. The Corruption Remedy Test Cases used Framing Fraud 22CA1074323 against Equity Lawyer Mr Ellis because it is the Crime Proceeds of Osteopath Misdescription Trial Frauds + Appeal Frauds got by the Bribery + Blackmail of Lord Mandelson. Worcester Crown Court Room 1 was the Crime Scene and Audio Records were Trial Fraud Conspiracy Proof against the Prosecutor, Court Officers, West Mercia Police Officers and Appeal Judges. Worcester Judges wanted Safe Conditions to evidence Duress Conditions got Court Frauds. The Trial Fraud Proof helped to get the Peace Plan Agreements, and Remedy Enforcement by Japan and the USA against Fraud Profiteers that financed the Post Office Scandal + Contaminated Blood Scandal. The Test Case got the Epstein Scandal + Mandelson Scandal + Starmer Scandal + Leadership Contest Denial Scandal + UK Premiership Appointment Fraud for Mr Burnham Scandal. The Makerfield By-Election Result motivated Worcester Judges used Bribe Allegations + Tax Enforcement Fraud Case 2026 00112 for a Conflict Disqualification Admissions.
3. The Corruption Remedy Test Case used the 1st + 2nd Ruin Fraud Conspiracy against Citizen Mr Nkrumah because:
 - 3.1. Mr Mandelson used Cabinet Office, and when he 2 Scandals lost that, Cabinet Influence, to manage the Business Expansion Plan for Performance Enhancing Drugs to Sports Professionals and Fitness Fanatics.
 - 3.2. It needed Ruin Frauds against Honest Competitors who had Influencer Status.
 - 3.3. Citizen Mr Nkrumah was an Honest Competitor with Influencer Status because he could beat Mo Farrah at some distances. Mo became a Sports Professional. Akwasi a BT Apprenticeship and was their Apprenticeship Marketing Model, and a Conservative Party Influencer to get out the Young Black Vote.
 - 3.4. The 1st Ruin Fraud was a Copyright Piracy Framing Fraud + 1st Offence Imprisonment Fraud + Ruin Fraud. The Citizen thought Racial Bias by Caucasian Police Officers was the fraud Motive until he discovered the Performance Enhancing Drugs Business Expansion Plan and Mr Mandelson was the Plan Manager.
 - 3.5. Lord Mandelson used Cabinet Office + Cabinet Influence to manage the Land Theft Expansion Plan for Network Agents against the State. The Start Fraud used House Title Transfers + Housing Charity Letting Agency Transfers from Local Authorities to Housing Associations + Title Proof Destruction + Title Record Fabrication + Housing Charity Asset Sales by Network Agents to the Housing Associations. Tenancy Forgery Complaints by Citizen Mr Nkrumah motivate the 2nd Ruin Fraud Conspiracy against him. Everything that could go wrong for the Fraud Conspirators did go wrong. Good Management by the Citizen + Service Refusals by Competent Officers + Bad Management by Incompetent Officers forced Mr Burnham to make Case Closure Frauds before he took office an Appointment Fraud Condition. It used Secret 2 Year Adjournment Frauds and then in 2 Cases a Secret Adjournment Revocation + Secret Jury Trial Acquittal Pretence Frauds. Process Notices from Court Officers got Trial Appearances by the Citizen that forced Jury Trial Exclusion Frauds against him with Video Records + Audio Records of Snaresbrook Crown Court + Central Criminal Court the Event Proof. It validates Budget Fraud Enquiries from the end backwards to the Forgery Complaints to years earlier.
2. The Corruption Remedy Test Case uses Ruin Fraud Conspiracies against Citizens Mr Coyle + Mrs Theodorou + Mr Say + Mr Sood + Others that serviced Network Business Expansion Plans managed by Mr Mandelson, later Lord Mandelson. Start with the Crown Court Frauds and work backwards.
